  - 2. High School Diploma & Transcript or G.E.D. Certificate & Report of Test Results. (Applicants who have completed an associate's degree or higher at an accredited college or technical school may submit an official transcript in lieu of a high school transcript or official GED test results.)
  - 3. Military transfer or Discharge Form DD-214, if applicable.
  - 4. Valid Driver's License & 5-year Driving Record obtained within last 30 days.
  - 5. WorkKeys Assessment in Applied Mathematics (minimum score of 6), Reading for Information (minimum score of 4) & Locating Information (minimum score of 4).
- D. Drug Free

Applicants will be required to appear for interview when scheduled.
